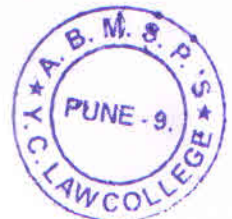

#### **Instructions:**

- The examination will be conducted online. All relevant communication related to examination will be done through the email on registered email address and SMS on registered mobile number. It is suggested not to change email address and mobile number till completion of examination April 2022 (**First Term**).
- Students can get hall ticket through their registered email.
- For physically challenged students for the online examination, time will automatically get set to 80 minutes. The physically challenged students can take help of assistant during the online examination.
- Candidate shall appear for the online examination from the place of their convenience.
- Candidate can log in using their mobile, laptop, PC or I-Pad. Please take care that batteries of these units are properly charged prior to examination and also connected through internet facility.
- In case of any technical difficulty during the examination, software support is provided by the college. On-line examination will get resumed for the remaining duration in case of technical interruptions during the examinations. Answers of the questions attempted by the student before occurrence of the interruption will get saved automatically on service provider's server. A mock test will be provided to all students. Time table of test will get communicated to students through college website.
- All questions are Multiple Choice Questions having single correct option.
- Each question carry 1 mark.
- Test duration – 60 minutes, Specially-abled Students are allowed 20 minutes more for examination. Attempt any 50 questions, Maximum marks assigned for the exam is 50 marks.
- Please make sure that, you make the final submission only after completing the examination. You will be asked to confirm, in case you accidentally try submitting the examination before the completion of the duration. Please note that once you make the final submission, you will not be able to take up the examination again.

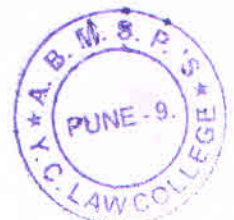
